Submission Guidelines

- The papers should be based on original research work, not yet published and must be made in word format (doc./docx.).
- Maximum number of authors is 2 per paper.
- The manuscript should not exceed 5,000 words (A-4 size pages typed in double space with justified alignment).
- The cover page should state only the Title of the Paper, Author's Name, Official Address, E-mail ID, Contact number of the author(s).
- Font: Times New Roman, Font Size: 16 for title, 14 for sub-heading and 12 for body.
- Authors are required to submit an Abstract of 250-300 words with 5 keywords.
- The participant should send the full manuscript to lawconference@kristujayanti.com on or before 30/06/2023.
- The selected papers will be peer reviewed and evaluated based on originality and relevance to the conference.
- Reference: APA (American Psychological Association) is followed for Education, Psychology, and Sciences, MLA (Modern Language Association) style is followed for Humanities, Chicago/Turabian style is used for Business, History, and the Fine Arts. Bluebook 20 edition / ILLI style is used for Law.
- Certificate of participation will be awarded only to those participants who attend the conference for both the days (offline) for all the keynote sessions.
