PUBLICATION GUIDELINES

- Papers are to be submitted via email to statsconference@kristujayanti.com
- Plagiarism to be avoided (to be restricted to <10%)
- Manuscripts (including tables, figures and photographs) to be typed in double space, single column, A4 size in MS Word doc file and a Pdf file, in Times New Roman font. (font size 12)
- Text should ordinarily not exceed 10 type written pages with relevant Photographs/Figures & Tables.
- Abstract of the paper in not more than 10 typed lines, should accompany the article.
- Key words, 4 to 7, important words that specifically describe the topic should be given.
- Tables should be self- explanatory and provided with a title and number.
- Figures, illustrations should be self-explanatory and provided with a title and number.
- Heading (title) of the manuscript should be concise and limited to about 15 words.
- References should be written in MLA style in chronological order, in the text giving only the number of reference. The reference should be given in an alphabetical order of author's name(s) and must be numbered serially.
- Author's address in the manuscript should be with email address.
- In future correspondence, the authors are requested to use the same email address to reply through which the paper has been sent & in which the communication has been in continuation. Corresponding author's name and address should be indicated with an asterisk sign (*) with Pincode and Mobile No.in the manuscript for future correspondence.
- Address of all authors in the manuscript should be with email addresses. In future correspondence, the authors are requested to answer in the reply box instead of sending fresh email.
