



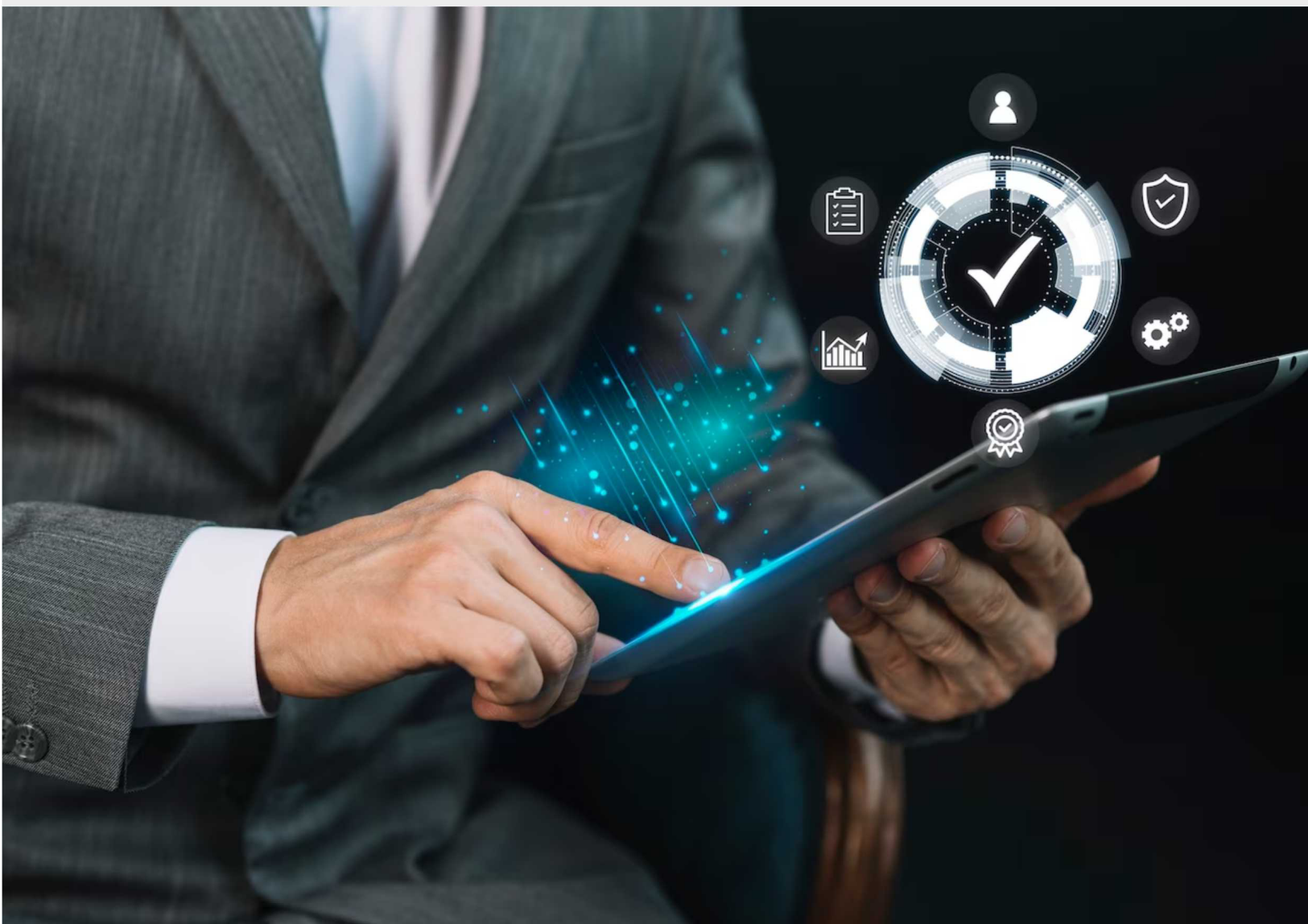

St. Kuriakose Elias Chavara was a nineteenth century educationist & social reformer in India. He played a major role in educating the people of the lower ranks of the society. He started a school at Mannanam in 1846. He was responsible for introducing noon day meals in schools, a practice later adopted by the rulers of Travancore & then by the Indian government.

Kuriakose Elias attained eternal peace on January 3, 1871, aged 66 at Koonammavu, a northern suburb of Cochin city. He was beatified at Kottayam on February 8, 1986 & later was canonized at St. Peter's Square by Pope Francis in 2015.

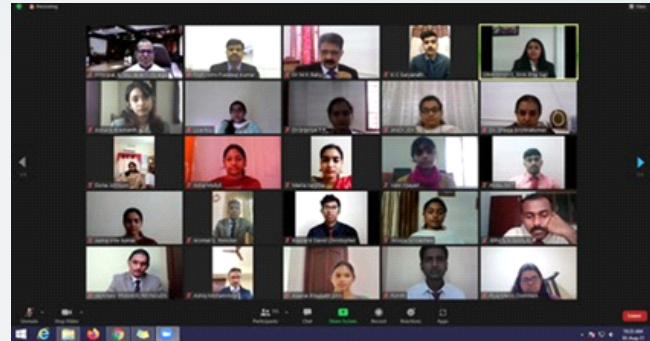

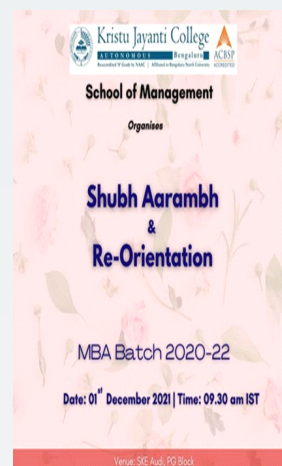
The Shubh Aarambh for the 1st year MBA C section students was organized virtually on 2nd February 2022 through Zoom Cloud meeting platform.

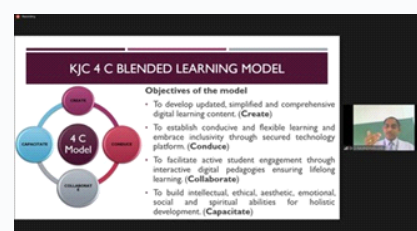
LMS Orientation

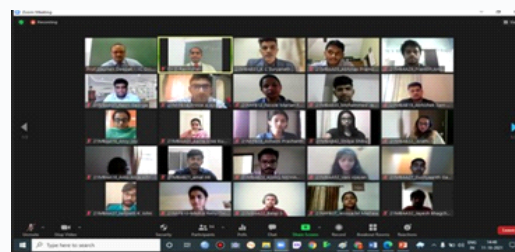
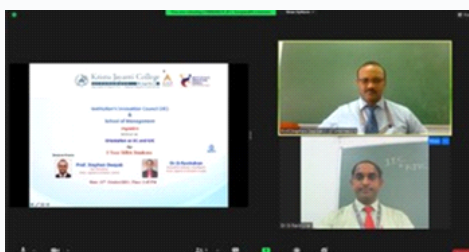
Orientation on IIC And KJIC

KRISYM – 2022

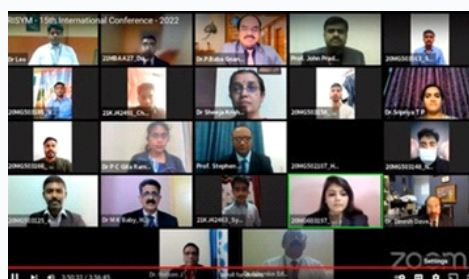

Keynote session 2: Dr Blair Whitmarsh

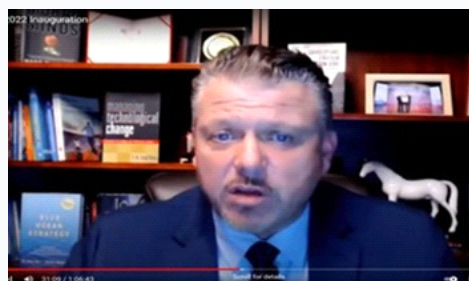

Ventura 2022 - Mentoring

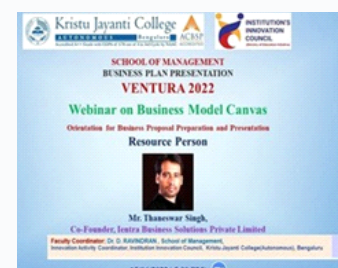

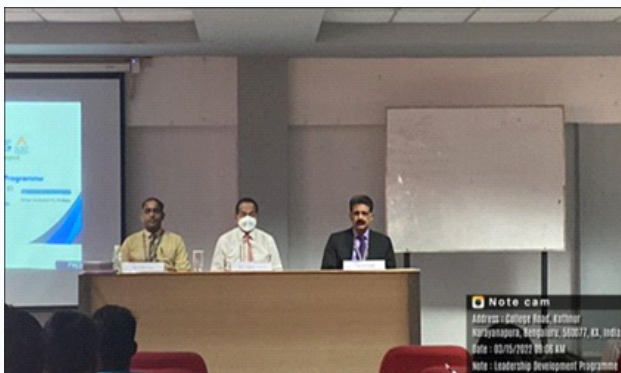
Leadership Development Programme

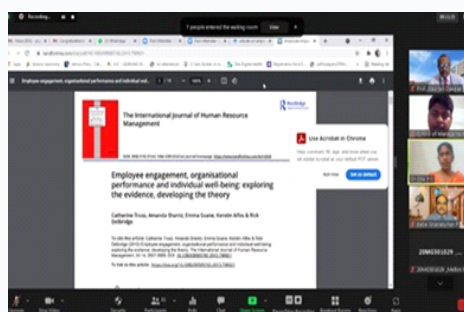
Workshop on Life Skills for Managers

Workshop on Research Methodology

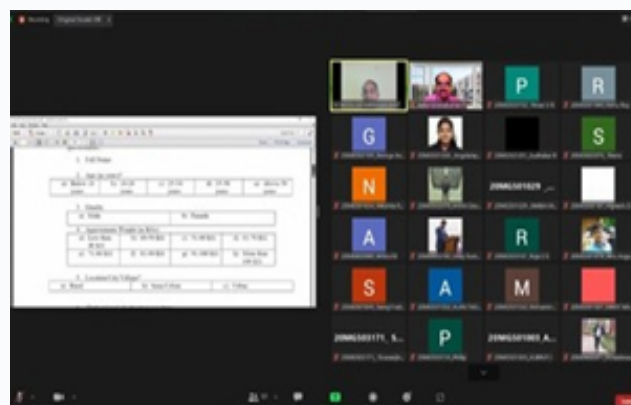

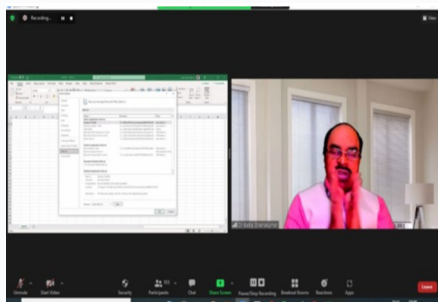

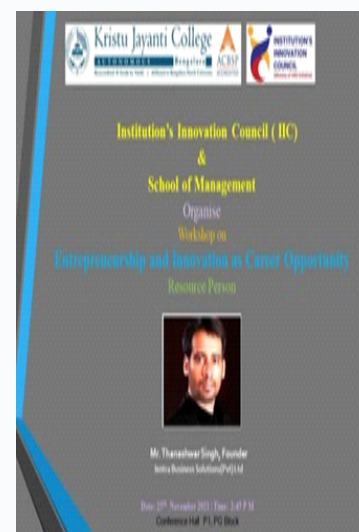
Workshop on Data Visualization



Kristu Jayanti School of Management organized Research Methodology Workshop III on Data Visualization on 13th November 2021 through the Zoom platform at 7.00pm. The resource person for the workshop was Dr Baba Gnanakumar, a faculty member from the School of Management. The workshop intends to enable the II year MBA students to analyze the project data efficiently. Sir explained the data analysis for secondary data. He stated the sources of secondary data for finance research and cited a few websites from where students can access the data. He demonstrated analyses using Microsoft Excel. He gave hands-on experience in data visualization using graphs. He explained how to analyze the students from various specializations like finance, marketing, human resource, and analytics. The session was highly engaging, providing the students with a clear understanding of how to visualize data using Excel.

Workshop on Entrepreneurship & Innovation as Career

Kristu Jayanti School of Management, organized in association with the Institution's Innovation Council (IIC), organized a workshop on Entrepreneurship and Innovation as Career Opportunity on 25th November 2021. The resource person for the program was Mr. Thaneshwar Singh, Founder, of Ientra Business Solutions Pvt. Ltd. the session was started by asking the students about the meaning of innovation. He quoted the motive with which one becomes an entrepreneur. He later shared his journey from being a marketer to an entrepreneur. He mentioned necessity is a key factor in becoming an entrepreneur. He stated that learning from mistakes is a very essential part of becoming an entrepreneur. Mr. Singh spoke about the incubation center of the college and how it provides a platform for the students to build their business ideas. The incubation center has helped students to come up with their start-ups. The session was very informative and inspiring and all the Jayantians actively participated in the discussion, by asking relevant questions.



Workshop on Life Skills for Managers



Kristu Jayanti School of Management organized the Life Skills for managers programme for the 1st year MBA Batch 2021-2023 Section C which was held from 3rd February 2022 to 5th February 2022. The Life Skills for Managers training Session consists of 10 interactive Life Skill Sessions - Self Awareness, Empathy, Creative Thinking, Critical Thinking, Problem Solving, Decision Making, Communications, Inter-Personal Relations, Coping with Emotions and Coping with Stress.

The Day one session consisted of 3 topics Self Awareness, Empathy and Creative Thinking, by the faculty members Prof. Sen B Mathews, Prof Stephen Deepak and Dr Baba Gnanakumar. On the second day, Critical Thinking by Dr Gita PC, Problem Solving by Dr Sripriya, and Decision Making by Dr D Ravindran, Communications by Dr Sheeja Krishnakumar and Interpersonal Relations by Prof. John Pradeep Kumar. The final session was taken by Coping with Emotions by Dr M. K. Baby and Coping with Stress by Dr Justin Nelson Michael. The Life Skills training programme came to an end by developing the skills and building up the confidence of each student.

Workshop on Aptitude Training Programme

Kristu Jayanti School of Management organized the Aptitude Training Programme for the 1st year MBA students in two phases, from 24th May to 30th May and 6th June to 17th June 2022. The expert trainers were from Bizotic Talent Solutions. This training programme is designed to improve the potential of students to pass the aptitude tests during the campus placement. The training session started with a pre-test to determine the knowledge baseline before commencing the training program. The topics covered during the session include number system, letter series, ratio proportion and partnership, number series, average, articles and prepositions, percentage, blood relations, profit and loss, subject-verb agreement, time and work, seating and data arrangement, time speed, and distance, analogy data interpretation, reading c+omprehension, simple and compound interest, sentence correction, ages, sentence completion, coding and decoding, direction sense test, change of speech and voice, probability, data sufficiency and ordering of sentences.



Workshop on Ms Excel

Kristu Jayanti School of Management organized Excel classes for the students of the I MBA batch 2021-2023. The inauguration was held on 9.03.2022 with the presence of Dr. Aloysius Edward. J Dean, School of Management and the resource person, Mr. Nandeesh Reddy, an alumnus from the 2019 batch. During the classes, the students learned about the introduction, scope, importance, and fundamentals of Excel. They were taught about the importance of count, sum, and average, as well as how to use conditional formatting, data validation, and dependent dropdowns. The students also learned about when to use appropriate lookup functions like VLOOKUP, HLOOKUP, and VLOOKUP with Match.



In addition, the students covered topics like IF and Nested IF and worked on more problems related to these functions, as well as VLOOKUP and Match. They also learned about Pivot Tables. At the end of the session, the students had a revision of all the functions learned in Excel, and the trainer clarified any queries they had individually. Overall, it seems like a comprehensive Excel course that will be beneficial for the students' future endeavors.

Workshop on Project & Internship

Kristu Jayanti School of Management organized a workshop on Project and Internship I to orient the first year MBA students (Section A,B and C) on June 2022, in mini auditorium. Dr. Aloysius Edward J., Dean, Faculty of Commerce and Management, spoke to the students about the process of identifying internships and research projects that are relevant to their field of study. Highlighting the importance of the internship for MBA students, Dr. Edward explained the project manual, key deliverables, and important deadlines. Assuring the students about the support that would be extended by the faculty guides, the School, and the College, he also gave an introduction to the internship that is being planned for the students to get internship placements. Dr. M. K. Baby, Head, School of Management, presented the complete internship schedule to the MBA students by commencing his speech with the details of the marks and credits allocated for the internship cum research project in trimester IV. Referring to the three stages of the Internship cum research project, Dr. Baby elaborated on the dates and deadlines for every activity were announced by him.



Workshop on Research Methodology-Project Orientation II

Kristu Jayanti School of Management organized a workshop on Research methodology- Project Orientation II for the first year MBA students (Section A, B and C) on June 24th 2022 by Dr. Justin Nelson Michael, professor and Director, Center for Research, Kristu Jayanti College, addresses the students about the process of identifying a company for internship and research projects that are relevant to their field of study. The session began with the importance of finding the right company and the significance of following all the deadlines. Sir stressed the marks carried between the dissertation and Viva-voice, and the initial steps that must be taken before joining the company for an internship. Highlighting the importance of collecting a letter from the company confirming the internship, Dr. Nelson also explained the project manual, key deliverables, and important deadlines for the deliverables. He also spoke in detail about the different chapters of the research report and the weightage of each chapter. Then students were provided with a useful list of e-resources to use for their research studies and a guide to avoid any plagiarism.

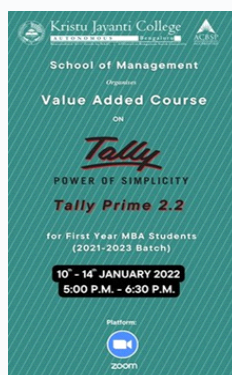


Value Added Course

Tally Training

The School of Management organized a value-added course on Tally Prime 2.2 from 10th January 2022 to 14th January 2022 through the Zoom platform. This course was offered to the 1st year MBA Batch 2021-2023 students. The resource person was Mr. Vignesh, Trainer, NICT Computer Education, Bengaluru. The course was coordinated by Prof. John Pradeep Kumar and Dr. J Peter Leo Deepak, faculty member of the School of Management. Features like 'Company Creation' and 'Company Features Alteration', 'Altering a Company', 'Shutting a Company', 'deleting a Company' and 'changing the date', 'Accounts Masters - Ledger Creation', 'Inventory Masters- Stock Group, Stock Category, Stock Item, Units of measure and Godown Creation', 'Voucher Posting' were demonstrated in Tally Prime.

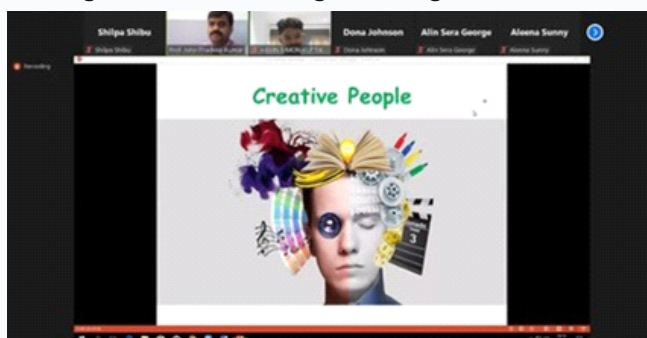
Ms. Priyanka, introduced the key concept of GST in Tally Prime and taught the fundamentals related to the GST concept in the Tally software, showing multiple examples of recording CGST, SGST and IGST in various scenarios. On the final day of the training, Ms. Priyanka had a quick revision of the fundamentals and the key concepts that had been learnt thus far.



After a brief revision of the same, the students had their Tally Prime online examination, comprising of 50 multiple choice questions, spanning over an hour. With the examination, the Tally Prime training came to an end. In the opinion of the students, the course was extremely beneficial and provided a lot of knowledge needed for the corporate segment. The course content and its delivery were carried out in a well-coordinated manner.

Design Thinking

The School of Management at Kristu Jayanti College organized an online value-added course titled "Design Thinking for Managers" for the first-year MBA students of batches 2021-23 from September 7th to September 16th. Ten sessions were focused on the different components involved in the design thinking process, which included empathy mapping, creativity myths and creative people, creative organizations, testing the ideas, impactful learning for innovation, design thinking for innovation, creating a prototype for managers, creating a design sprint, distributed creativity, and the impact of ideas. The first session on empathy mapping was taken by Dr. Baba Gnanakumar, who gave an understanding of what design thinking is, which is the first step in the whole process. Prof. John Pradeep Kumar broke down the creation myths and took us through who creative people are and their characteristics. He encouraged people to believe in creativity and also showed them how to develop it and come up with ideas. The third session on creative organizations was led by Dr. Gita PC, who taught how different companies and creative organizations use design thinking to transform themselves.



Testing the Ideas was the fourth session in which Dr. D. Ravindran conducted an activity wherein students were split up into 10 groups and had to come up with an idea and pitch it to the ten other students who were angel investors. Dr. Justin Nelson took the next session on Impactful Learning for Innovation, where he explained to us that there are no bad ideas and what we must focus on is whether our ideas can create an impact. The sixth session on Design Thinking for Innovation was one where we were given a deeper understanding of what innovation is by Prof. Sen B. Matthew. The final session taken by Dr. M. K. Baby was solely for the presentations by the students, where we heard the different innovative ideas using design thinking.

Universal Human Values

Kristu Jayanti School of Management conducted a Value Added course on universal human values for the first-year MBA students of Batch 2021-23 from September 6, 2021, to September 15, 2021. The faculty members of the School of Management served as the resource persons. The Universal Human Values course was initiated based on the guidelines from AICTE. The course was mooted with the following objectives:

Development of a holistic perspective based on self-exploration about themselves (human beings), family, society, and nature/existence.

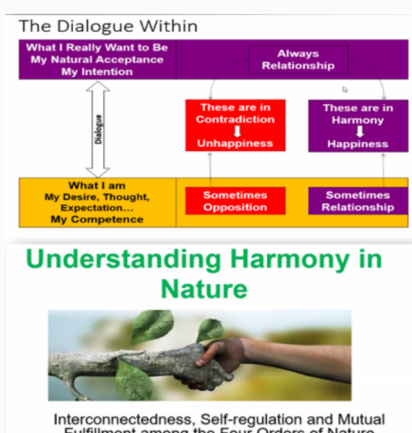
Understanding (or developing clarity) of the harmony in the human being, family, society, and nature/existence.

Strengthening of self-reflection and development of commitment and courage to act.

Annotating human emotions and experiences with individuals, families, society, and nature.

Interpreting life circumstances to adopt the right attitudes and behaviors for holistic living.

The course described human experiences at the individual, family, society, and natural levels. The interactive sessions gave students more insights and enabled them to explore life through their own experiences. The students were assessed through a daily test at the end of the day's session, and they had to submit a descriptive essay assignment based on the learning outcomes of the course.



Lean Six Sigma Green Belt Certificate Program

School of Management, Kristu Jayanti College, organized a Lean Six Sigma Belt Certification Program for MBA students of batch 2020-22 from March 12-16, 2022. The school has a tie-up with KPMG India Private Limited to conduct sessions for the students to build and sharpen their skills and their relevance in the fields of manufacturing, production, and operations. The classes were conducted by a reputed professional Six Sigma Black Belt Master, Mr. Lakshya, Manager, KPMG India. The entire MBA batch of 2020-22 has three sections. Sessions were conducted section-wise every day on separate time slots. The training was split topic-wise, and a schedule was prepared accordingly.

On the first day, the instructor introduced Six Sigma and its relevance in manufacturing, production, and operations.

On the second day, the instructor focused on the "measure" phase and introduced the software Minitab.

On the third day, the instructor discussed the "analyze" phase, including root cause analysis, Lean theory principles, and the control impact matrix, as well as Chi-Square, Regression, and Correlation.

On the fourth day, the instructor focused on the "improve" and "control" phases. They discussed various methods for generating ideas, such as brainstorming and turncoats, as well as the Theory of Inventive Problem Solving (TRIZ), Kaizen, Kanban, the Poka-Yoke model, the statistical process model, and various types of charts. The instructor also provided exam-style questions to prepare for the exam.



Data Analysis Using Spreadsheets

The school of management of Kristu Jayanti College (Autonomous) held a three-day session on the topic of Data Analysis using spreadsheets from September 16th, 2021, to September 18th, 2021. The seminar covered five data analyses and was presented by a faculty member from the school of business. The speaker, Dr. Sripriya, of the school of management made it a very clear and vital session. This session was focused on the first-year MBA students. During the session, the attendee shared the basics and practical knowledge regarding the topic.

The main focus of this program was to give them a thorough understanding of data analysis using spreadsheets and how useful it will be in their lives. The five topics that were covered are namely: data handling using Excel, data visualization using Excel, data analysis using Excel, data analysis using SPSS, and analytics using SPSS.



Student Knowledge Enrichment Programme

Contribution of Nobel Laureates In The Field Of Economics For 2021

SKEP was hosted by the School of Management of Kristu Jayanti College (Autonomous) on 25th October 2021, at 2.45 p.m. on the Contribution of Nobel laureates in the field of Economics for 2021. The presenters were Jisha Jogi Mammen, Reyon Immanuel, and Prince A Aji of MBA Batch 2021-2023. The program started with an introductory note by Ms. Moumita Goswami, who asked specific questions to the audience that formed the prelude to the contributions made by the Nobel laureates. The presentation started with Prince introducing the significance of the Nobel Prize and giving a biographical sketch of the three laureates, David Card, Joshua D. Angrist, and Guido W. Imbens. Reyon Gifto Immanuel and Jisha Jogi Mammen explained the contributions of David Angrist and Guido W. Imbens and their empirical contributions to labor economics.



Air India Takeover by Tata Sons



Kristu Jayanti School of Management organized a session on the Air India Takeover by Tata Sons on October 28, 2021, to enrich students' knowledge by giving them opportunities to research and present their views on contemporary topics in the business world. Ms. Aaina Sree Kumar started the session by explaining India's aviation sector and its history and operations. Then the session

was taken over by Aarathi P, who went on at great length about how TATA built India and the two centuries of business. Ancy Joy handled the last session of the presentation. She dealt with what the Air India acquisition means for TATA and the final takeover.

Unicorns of India – 2021

The School of Management organized a session on the topic Unicorns of India – 2021 on 4th November 2021. Pandora Papers

The next speaker was Abhishek Biyani, who started his session by giving a brief explanation about how the Pandora Papers were discovered and how the investigation led to the biggest scam in the world. The session was carried forward by the next speaker, Ashwin Kumar. He spoke about the impact of tax havens on the Indian economy. He presented the initiatives taken by the government to control these kinds of scams.

Sports as a Business, Case study of IPL

The School of Management of Kristu Jayanti College (Autonomous) scheduled a Student Knowledge Enrichment Program on the topic of Sports as a Business: A Case Study of the IPL on November 29, 2021. The presenters were Reon George, Nicole Marian Fenwick, and Jemimah Percely of MBA Batch 2021–2023. From Start-Up to Listed Companies – A Case Study on Zomato and Nykaa

Then he gave the details of the IPOs of Zomato and Nykaa.

Visit to Refuge Foundation

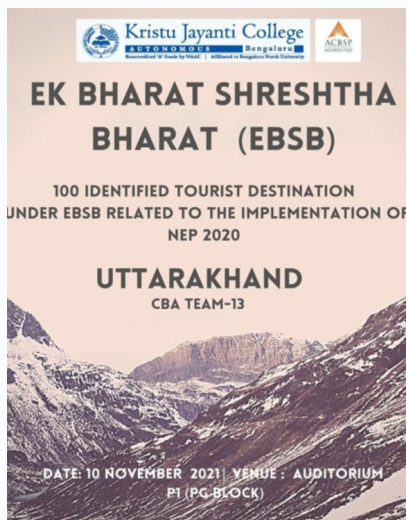

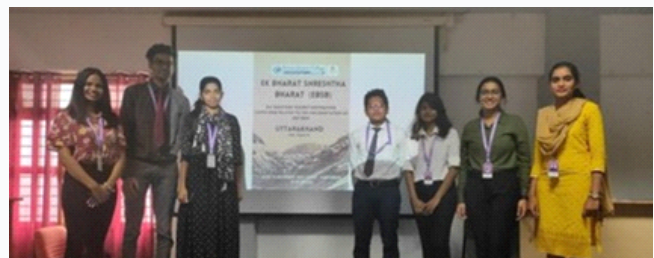

On the 28th of May 2022, Kristu Jayanti School of Management organized an industrial visit for the first-year MBA students from Section C under the guidance of the faculty coordinators, Dr. Peter Leo Deepak J and Prof. Sen B Mathew, to TIA Technology India Private Limited, Nelamangala Taluk, Dobaspet P.O., Bangalore Rural. 80 students were divided into two batches; the first batch attended a formal introduction session in the conference hall about the company, and they also learned how their processing works. The other batch of 40 students was taken to the manufacturing unit, and they started to explain their process. TIA Technology explained the processes or steps involved in the manufacturing of goods. They started by stating some of the most important tasks performed in the unit: weighing, filling, and packing. They mentioned that almost all the raw materials used in the manufacturing unit are produced by the company, but other than that, they do get other equipment imported..



The manufacturing unit uses different technical equipment to make the work of humans easier or to reduce human intervention. 100 grams to 2 metric tons can be weighed. The machinery used is automated as well as semi-automated. One of the main fully automated machines they use is called a backfilling machine. This machine consists of two fillers, one of which is an open-mouth bag filler that is used for the free flow of granular products such as salt, sand, rice, and so on, and a twin-screw feeder for powdered products. The granules are then packed, sealed, and weighed, and

then taken to storage locations by automated machines again. In the event that the weight is not balanced, the machine discards the product. All these procedures are fully automated, making the processes easier and increasing the productivity of the company.

On the 28th of May 2022, Kristu Jayanti School of Management organized an industrial visit for the first-year MBA students from Section C under the guidance of the faculty coordinators, Dr. Peter Leo Deepak J and Prof. Sen B Mathew, to TIA Technology India Private Limited, Nelamangala Taluk, Dobaspet P.O., Bangalore Rural. 80 students were divided into two batches; the first batch attended a formal introduction session in the conference hall about the company, and they also learned how their processing

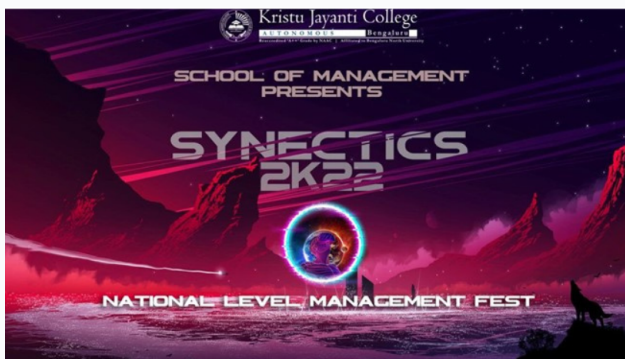

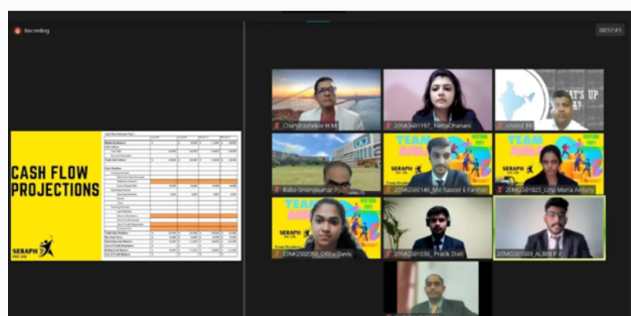
Kristu Jayanti School of Management organised 'Abhigyan - Management Concepts through Theatre' on 01st June'2022 d for first year MBA C section students. .

73rd Republic Day Celebration – Azadi Ka Amrut Mahotsav

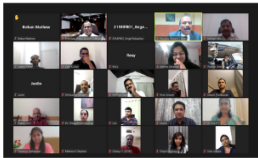

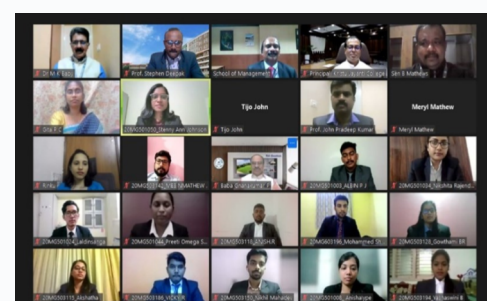

Alumni Industry Mentorship (AIM)

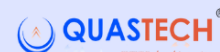
