Admission to Ph.D Programme in Commerce

Eligibility: Doctor of Philosophy in Commerce is open to applicants who possess a Master's Degree in Commerce Discipline or an equivalent qualification and as per Bengaluru North University

Admission Procedure: Doctor of Philosophy in Commerce is applicable for the candidate who possesses the basic eligibility as per the Bengaluru North University guidance.

Application: The Application and procedure to submit should be done according to Bengaluru North University requirements

Fee: Fee prescribed by the University for the Ph.D. programme according to the information from Bengaluru North University

Course Work: Course Work prescribed as a part of Ph.D. programme and which all the candidates shall successfully complete as a pre-requisite for confirmation of registration.

Publications: As per the norms set by the University Grants Commission (UGC), each doctoral student is expected to have a research article accepted for publication in a peer reviewed journal deemed appropriate by the Doctoral Committee prior to the award of the Ph.D Degree.

Doctoral Committee: means the Committee constituted by the University to consider the half yearly progress report, permit change of title, permit change of research supervisor, permit extension of time to submit the thesis, to issue show cause notices if required, to give permission to submit the thesis and such other duties entrusted by the University to the Committee from time-to-time in connection with the Ph.D. programme

Thesis: On the completion of the research work the Ph.D. thesis has to be prepared according to the format provided prescribed by Bengaluru North University.

Submission of Dissertation: The Candidate are expected to submit the thesis as per the format given by the Bengaluru North University

Viva-voce: On the receipt of the favourable/satisfactory reports from the external adjudicators, an open viva-voce examination shall be conducted on any working day by a Board constituted by the University. The viva-voce examination shall be conducted by the research supervisor with at least one of the two external examiners.

General Guidelines: The Ph.D. candidates are required to strictly adhere to all the procedures and requirements as prescribed in the regulations. Every Ph.D. candidate is expected to procure/download a copy of the Ph.D regulations, and be familiar with all the rules, regulations and requirements. Ignorance of the rules, regulations and requirements shall not be accepted as an excuse for any technical lapse on the part of the candidate.

Pursuant to the resolution of the Syndicate at its meeting held on 27-06-2018 and in exercise of the powers conferred under Section 66 of the KSU Act 2000, the Bangalore University hereby accords recognition to Kristu Jayanti College (Autonomous), K. Narayanapura, Kottanoor Post, K.R. Puram, Bengaluru-560 077 as Research Centre for conducting research leading to Ph.D. programme in *Psychology and Commerce from the year 2016-17 to 2019-20*, subject to the following conditions:-

- The Centre should follow the Regulations Governing Doctoral Degree Programme of the Bangalore University and carry out the Ph.D. Programme as per the regulations as modified from time to time.
- A Research Advisory Committee (RAC) should be set up with the Chairperson of concerned P.G.
 Department of the University. This Committee should meet twice a year, preferably in May and
 November, so that progress reports of research students are scrutinized and forwarded through
 the committee.
- The observation/conditions as laid down by the Expert Committee of the Bangalore University in their report have to be fulfilled, a compliance this regard shall be sent to the University within 15 days of the receipt of this notification.
- The Centre should submit an undertaking in the enclosed proforma within 15days of the receipt of this notification.
- The Centre will have to pay the prescribed annual affiliation and other fees (for Ph.D., programme), to the Bangalore University and seek renewal of recognition once in four years.
- 6. Guest/Temporary faculty of the Department are not eligible to guide students.
